November 14, 1922 - June 9, 2012

David was born on November 14, 1922 in Torrington, Wyoming the son of David Merton and Mable Marie (Ackerman) Kellam. He grew up and received his education in Torrington. He went on to attend the University of Wyoming at Laramie and then the University of Texas where he graduated with a degree in Pharmacy. Dave also served in the Pacific Theatre in the US Air Force during WWII. He married Jean Northcutt on August 31, 1947 in Silverton, Texas. Dave and his wife Jean owned Kellam & Kellam Pharmacy for many years. They were also owners of Torrington Turf Farm for several years. David was a member of the First Wyoming United Presbyterian Church, a member of the Torrington Masonic Lodge, the Torrington Shrine Club, Travis Snow Post #5 of the American Legion, Paul A. Johnston Post # 2918 of Veterans of Foreign Wars and the Torrington Volunteer Fire Department. Dave also served as past Board member of the Tri-County Federal Savings & Loan Bank and also served as past City of Torrington council member.
